Shadowbrook is going to pay the extension. Brief discussion was held regarding fees to charge them.

Working with Harger to get them to do the work and also mobilize to the two properties.

Hydrogen Sulfide – received quotes for odor control system.

Flushing Connections – 2 valves broke over the winter. One has been fixed; one located at Marina Drive is temporarily fixed.

Grinder pumps for two locations - waiting on quote from Harger. Discuss cost to charge property owners.

Costream SCADA – Dave Smith is currently working with Shaun on this. Shaun is also exploring alternative support options. The license is owned by us.

Grinder pumps awaiting warranty work.

LDG we are holding money due to deficiencies.

DEP extension – still waiting on DEP.

Nutrient Offsets – still working on this.

Hillbilly Village – still waiting on the owner for drawings.

Discussion regarding LDG deficiencies – screener and valves.

John brought up office hours for the building. Discussion held and currently office hours are not necessary.

Discussion about identifying a replacement to take over my seat on the board.

Office repair update - Wire shelving will be installed in the closet office furniture has been repaired.

Dave Smith asked if we can do some of the testing on site that we go through Microbac for. Pay quite a bit for having it tested.

Dave Smith made a motion to adjourn seconded by Veto Barziloski and all in favor.
