Inspect other flushing connections.

Received quotes from Harger for drilling 2 laterals for the two properties not connected.

Brief discussion on how to handle charges for future hot taps. 25 Indian Springs Road is interest in connecting. What are we going to charge new properties that want to connect? State has a tap fee formula. Keep at current price until contract is closed out for the grinder.

Brief discussion regarding 14 Glowatch property

Requests for new sewer connection – Werkheiser campground – have not heard anything
more to date. 25 Shore drive is exempt due to the length of the lateral. Robic to go through
the proper procedures within the township and county.

CoStream Scada – looking for new option

Grinder pump and control panels – need to review those under warranty work

Need to review deficiency items from LDG

Brief discussion regarding backyard extensions on Shore and Marina Drive that were dropped by PennVest funding due to DEP requiring us to do planning.

Still reviewing properties for offsets

Screener – we don't use it. Valves are going to have to be replaced soon.
